

MyTOWN 'Colours of Togetherness – Digital Creative Art Contest' ("Contest")

16 August – 30 September 2023 ("Contest Period")

Terms and Conditions

1. The Contest is open to all shoppers of MyTOWN Shopping Centre age 7 years old and above ("Participants"). Participants below the age of 18 years old shall obtain consent from their respective parents/legal guardian prior to the participation. Non-Malaysians with a valid passport, residential address in Malaysia, and hold a Malaysia bank account are allowed to participate.
2. By participating in the Contest, the Participants and/or the parents/legal guardian agree to be bound by this Terms and Conditions and any rules and regulations of the Contest made by the Management.
3. Participating Rules:

 - b) Registration shall be made as individual and not through school or university.
 - c) Fill up all information required and select the category based on participant's age:
 - i. **Category (A1):** Primary School (7-9 years old)
 - ii. **Category (A2):** Primary School (10-12 years old)
 - iii. **Category B:** Secondary School (13-17 years old)
 - iv. **Category C:** Open Adult (18 years old and above)
 - d) For **Category (A1) & (A2)**, each account will only be applicable to register for maximum 2 participants with parent/legal guardian's consent. For **Category B and C**, each account only for 1 participant.
 - e) Download the pdf file provided and you may begin your colouring with your choice of medium such as colour pencil, crayon, water/poster colour for **Category (A1), (A2) & B**. For **Category C**, you may colour with your choice of medium such as colour pencil, crayon, water/poster colour or digital colouring
 - f) Participants from **Category (A1) & (A2)** are encourage to add own elements to complete the whole artwork, while **Category B & C** are compulsory to add own elements to complete the artwork.
 - g) Submission of artwork can be done any time through MyTOWN website once completed before 15 Sept 2023. Late submissions will not be accepted.
4. **Voting Rules:**
 - a) **Voters will register via the same link and each registered voter is given 2 votes** to vote their favourite ones.
 - b) Voting can only be done from 16 Sept 2023 – 24 Sept 2023.
5. Entries will be judged equally based on:
 - a. **Category (A1) & (A2)**
 - i. Use of Media (technique, choice of medium) 50%
 - ii. Colour Scheme 30%
 - iii. Overall presentation 20%
 - b. **Category B & C**
 - i. Use of Media (technique, choice of medium) 30%
 - ii. Composition and design of added elements 30%
 - iii. Colour Scheme 20%
 - iv. Overall presentation 20%
6. **Total scores** will be the sum of **total LIKES** on microsite and **total marks given by judges**. Judges' decision is final, conclusive and binding. No further appeal, enquiry and/or correspondence will be entertained.

- b. Colour Scheme 30%
- c. Overall presentation 20%

For Category B & C

- a. Use of Media (technique, choice of medium) 30%
- b. Composition and design of added elements 30%
- c. Colour Scheme 20%
- d. Overall presentation 20%
