

# MyTOWN 'United by Culture' Tradition in Frame ("Contest")

1 August – 31 August 2024 ("Contest Period")

## Terms and Conditions

1. The Contest is open to all shoppers of MyTOWN Shopping Centre aged 3 years old until 17 years old ("Participants"). Participants shall obtain consent from their respective parents/legal guardian prior to the participation. Non-Malaysians with a valid passport, residential address in Malaysia, and hold a Malaysia bank account are allowed to participate.
2. By participating in the Contest, the Participants and/or the parents/legal guardian agree to be bound by these Terms and Conditions and any rules and regulations of the Contest made by the Management.
3. Participating Rules:

  - b) Registration shall be made as an individual and not through school or university.
  - c) Fill up all information required and select the category based on participant's age:
    - i. **Category A:** Kindergarten (3-6 years old)
    - ii. **Category B -** Primary and Secondary School (7-17 years old)
  - d) For **Category A & B**, each account will only be applicable to register for a maximum of 2 participants with parent/legal guardian's consent.
  - e) Participants must take a photo of them in a cultural fashion (Malaysian traditional or national clothes).
  - f) Participants are encouraged to get inspiration from the States' costumes (such as Puteri Perak, Che Siti Wan Kembang, etc).
  - g) Submission of the photo can be done any time through MyTOWN website once completed before 16 August 2024. Late submissions will not be accepted.
4. **Voting Rules:**
  - a) **Voters will register via the same link and each registered voter is given 2 votes** to vote for their favourite ones.
  - b) Voting can only be done from 17 August 2024 – 21 August 2024.
5. Entries will be judged equally based on:
  - a. **Category A**
    - i. The uniqueness of the costume 50%
    - ii. Completion of the costume from head to toe 30%
    - iii. Overall presentation 20%
  - b. **Category (B):**
    - i. The uniqueness of the costume 30%
    - ii. Completion of the costume from head to toe 30%
    - iii. Posing 20%
    - iv. Overall presentation 20%
6. **Total scores** will be the sum of **total LIKES** on microsite and **total marks given by judges**. The judges' decision is final, conclusive and binding. No further appeal, enquiry and/or correspondence will be entertained.
